#### ADMX Templates for Office 2016 [D. Henninger] - Approved

#### Service Account for Puppet Enterprise [B. Beaudoin] - Approved

• Read-only account to go NCSU-Read Group Memberships group. Name to be provided using AD naming convention. Previous account for Puppet was for PCI compliance.

**SCCM Client Upgrade [M. Underwood]** - Plan is to upgrade the site (v1602) on June 22nd at 1:00PM. Hope to upgrade clients starting on June 29th.

- After the upgrade, there will be a console change notifying you of an update. Close and it will auto-update.
- Suggestion to create opt-in special configuration group to have 50GB cache set on client-side.

**Change Management [J. Gira]** - Define standard updates that do not require policy approval. Expectation is a list will be created, where examples can be added as topics come up. Define where change is documented and how it is shared.

 Verdict per discussion: OS, MS Office, and Google ADMX's should not require approval by the Policy Committee. Office ADMX's will not require approval, but unlikely to be added without an explicit request. Unless explicitly added to exemption list, any remaining ADMX request must be submitted and approved by AD Policy. All proposed changes to be vetted Sysnews post to follow addition.

#### Enabling IPv6 on the domain [M. Underwood] - Approved

• Previously disabled due to latency issue when initially released. Microsoft assumes IPv6 to be enabled. Assuming priority can be set for IPv4 or unconfigured IPv6, this will be approved. Sysnews post two weeks prior to the change.

**Endpoint Protection Standard in SCCM [M. Underwood]** - This service is alternate option to Kaspersky (ONLY impacts Windows 10). It does not include web reputation protection. A proxy server would be needed for an equivalent to Kaspersky.

Michael to provide the central policy already vetted and approved by S&C. Security and Compliance to vet/approve future exception request for the file/folder protection. Additional policies will be additions, proposed by individual colleges/units. Endusers will only have the ability to change when their scan occurs.
